# The Program

## Overview

Embarking on a transformative academic journey throughout Europe offers the opportunity to expand one's intellectual horizons while immersing oneself in a rich tapestry of cultures and experiences. The European Triple Bachelor in Economics and Business (EU-TriBE), is a three-year program offered by three prominent institutions: Luiss University in Rome, the Solvay Brussels School of Economics and Management of the Université libre de Bruxelles (ULB) in Belgium, and Goethe University in Frankfurt, Germany.

EU-TriBE presents a unique opportunity for students to attain three nationally accredited degrees. The students will be graduating with a:

- Bachelor's Degree in Economics and Business from **Luiss**;
- Bachelor's Degree in Economics from the **Université Libre de Bruxelles**;
- Bachelor's Degree in Economics and Business Administration from **Goethe**.

The program features a structured pathway spanning three years, with each year conducted at a different university, which encourages students to engage deeply with diverse cultures and educational systems. Over the span of two consecutive academic years, participants will have the opportunity to experience the academic and cultural richness of three captivating and dynamic cities located in the heart of Europe, thereby deepening their understanding of economics and business within varied contexts. Luiss students will follow a tailored study track based on their home university, further enhancing their academic journey:

- First year (2024/2025) at Luiss;
- Second year (2025/2026) at Solvay;
- Third year (2026/2027) at Goethe.

# Academics

## Program Rules

### GENERAL RULES

While every effort is made to provide students with complete, accurate and timely information, Luiss, Solvay and Goethe reserve the right to change, amend, modify or revoke the following Program Rules and Student Handbook.

The Program Rules are aimed at students enrolled in the first year of the Bachelor's Degree in Economics and Business in the a.y. 2024/2025 and taking part in EU-TriBE.

Interested students are required to read and understand the study plan and the Program Rules. These are to be considered binding to the successful completion of the

program. Changes to the study plan are usually not possible and any request in this sense must be conveyed to the International Development Office, that cannot guarantee its feasibility.

The list of courses to be taken abroad may be subject to changes should the academic offer at Solvay and Goethe be amended.

Luiss is not responsible for any cancellation or modification due to events beyond its control. If the program is cancelled or modified for these reasons, Luiss will inform all interested students in a timely manner.

### REGULATIONS

As a general principle, students are subject to the Academic Regulations of the University where they are studying in each academic year. These regulations apply not only to the Academic Activities, but also the rights and duties of the student, such as data protection, withdrawal or leave of absence, progress of study, etc.

- **Luiss:** students are subject to the University Academic Regulations, the Code of Conduct and the Code of Ethics.
- **ULB:** students are subject to the General Study Regulations and the Student Discipline Regulations of the current year.
- **Goethe:** students are subject to the Examination Regulation Bachelor of Science in Economics and Business Administration.

## PROGRESSION OF STUDIES

Selected students will be required to take all credits listed in each academic year at the university where she or he is studying within the academic year (excluding the retake session in August / September). Failure to do so implies withdrawal from the program and return to their home institution, which can recognize credits taken abroad at their own discretion according to its own procedures and policies.

## ATTENDANCE

### Solvay Brussels School of Economics and Management (SBS-EM)

- No compulsory attendance for courses, but exceptions exist when professors specifically request compulsory attendance pour group, oral, or exercise sessions for instance.
- For exams, students that decide not to take an exam can be given an “attendance note” if they request it directly to the professor. Otherwise, they will be registered as “absent”: an absence can be justified or unjustified only for information to the deliberation jury.

### Goethe University

- Attendance of classes is only compulsory in seminars.
- Final exams can only be taken after the corresponding courses have ended.

## EXAMS AND RETAKE POLICIES

### Solvay Brussels School of Economics and Management (SBS-EM)

- Examinations are divided into two sessions.
  - The first session takes place in two different periods, one in January and the other in June.
  - The second session takes place between August and September.
- Students are permitted to take an examination multiple times, provided the associated course is a component of their annual academic program. Each examination may be undertaken twice within a given academic year: once in the first session, which may occur either in January (semester 1) or June (semester 2), and once more in the second session during August.

- The content of the annual academic program is determined based on the remaining credits required for the completion of the respective program cycle. First-year courses must be successfully completed within the first two years of the bachelor’s program, while all program courses must be completed within a maximum timeframe of five years.

### Goethe University

- Students can take each exam a maximum of three times and afterwards they are expelled from the program.
- The specific assessment criteria for each individual course will be delineated in the respective course syllabus.

## CREDIT TRANSFER

Students will graduate from all three universities upon the successful completion of all required credits for each degree, in accordance with the assessment criteria for each course or activity. This must be achieved by the conclusion of their third year in the program. The home institution reserves the right to recognize credits earned abroad at its discretion, in accordance with its own established procedures and policies.

## Final Work / Thesis and Graduation

### GRADUATION REQUIREMENTS:

- Students will only graduate from all three universities upon successful completion of all credits necessary for each degree. This includes adhering to the assessment criteria stipulated for every course and activity by the end of the third year of the program.
- Students will complete the final work / thesis during the third year of the program (2026/2027) at Goethe University.

### SUPERVISION

#### Luiss

- Luiss will establish an academic commission composed of three faculty members, each representing one of the specializations or tracks: Economics, Finance, and Management.
- This commission will also function as part of the Luiss graduation commission. Their responsibilities include assigning a grade according to the Luiss grading scale while considering the assessment provided by the supervisor at Goethe University.

No thesis supervision is expected from **Solvay**.

#### Goethe University

- Students can apply for a thesis supervisor during the second semester of their third year.
- As part of the application process, students may indicate up to five preferences for their supervisor.
- Supervisors are assigned based on these preferences; however, if a student does not receive any of their preferred supervisors, an alternative supervisor will be appointed.
- The assigned supervisor will collaborate with the student to define the thesis topic and outline the structure of the thesis.

### GRADUATION

#### Luiss

- EU-TriBE students are not eligible for graduation at Luiss in the Summer Session 2026/2027 (July). Therefore, the earliest graduation session will be in Autumn 2026/2027 (October / November).
- Approximately 2 to 3 months after the official graduation date, a non-mandatory graduation ceremony is held in Rome. Students have the option to collect their diplomas on this day.
- Should a student choose not to attend the graduation ceremony, the diploma will be mailed to their designated home address.

#### Solvay Brussels School of Economics and Management (SBS-EM)

- The deliberation takes place in the beginning of September.
- The graduation ceremony is scheduled one month later, in October.

#### Goethe University

- Grades are typically released by the end of August.
- The deliberation process and official graduation can occur anytime following the submission of the thesis.

## Housing

The university does not provide accommodation, so students are responsible for finding their own housing. However, it is possible to apply for student dormitories, subject to availability.

SBS-EM can help providing housing on campus and in private residences but does not guarantee housing to any incoming students. It is essential to begin the search for accommodation well in advance, as availability can be competitive. ### Goethe University

Goethe does not guarantee housing to any incoming students, while it will do its best to support the student in finding suitable accommodation. Available options:

- Studierendenwerk residences
- Private residences
- Private apartments

The student services association "Studentenwerk" plays a vital role in managing student accommodation in Frankfurt, overseeing over half of the city's dormitories. With seventeen dormitories providing more than 1,850 rooms, students from Goethe and two other local universities have a range of options for their housing needs. The residence halls cater to diverse preferences, offering everything from single rooms and private apartments to shared accommodations. Due to limited capacity in dormitories, many students opt for private housing arrangements. A popular choice among students is to live in Wohngemeinschaften (WGs), or shared apartments, which foster a community environment. ## Financial Arrangements

Tuition Fees for the 2024/2025

### Academic Intake:

- Students will pay standard tuition fees to Luiss during the entire three-year period according to the rules of the university.
- Students are required to pay the Italian regional tax, which amounts to approximately 156€, every year. Additionally, students in their third year of study are required to pay a graduation fee of 200€, in accordance with the official timeline and regulations set forth by Luiss.
- During their year of studies at Goethe, students are required to pay a contribution to the student service association “Studentwerk” and the obligatory semester ticket for local and regional public transport (300€ per semester).
- All expenses related to the participation in the program, notably transport to and from the host universities, accommodation and food, administrative expenses, costs associated with securing a visa, medical/health/accident insurance, books, application fees or deposits, and personal expenses, will be borne by students.
- Luiss University will provide Erasmus funding for students during their first year abroad, as well as additional university funding for their second year abroad.



## COST OF LIFE

### SOLVAY BRUSSELS SCHOOL OF ECONOMICS AND MANAGEMENT (SBS-EM)



**Housing:** typically ranges from 350€ to 500€ per month, depending on the type of housing and the level of comfort. A rental deposit of one to three months' rent may be required by the landlord.



**Meals:** Average monthly budget of 400€. There are also many food services on campus with low prices.



**Public transport:** The monthly cost for students is 40€. A single ticket (buses/underground) cost is 2,20€.



**Books:** Average cost for books and learning material per month is 35€.



**Cinema:** Usual cost between 9,50€ and 12,50€.



**Theaters and concerts:** The average ticket cost is between 15€ and 30€, but many associations give students reduced prices.

### GOETHE UNIVERSITY



**Housing:** Typically costs around 450€ per month.



**Meals:** Average monthly budget of 200€.



**Public transport:** Costing approximately 300€ per semester.



**Books:** Average cost for books and learning material per month is 40€.



**Cinema:** Cost around 10€.



**Theaters and concerts:** Tickets for theaters, operas and concerts, ranging from 10€ to 30€, with student discounts frequently available.

# Selections & Admissions

## Overview of the selection process

The selection process for Luiss students will be detailed in a Call for Applications, that will be published in the first half of December in the [program website](#).

EU-TriBE is open to students enrolled in the first year of the Bachelor's Degree in Economics and Business in the academic year 2024/2025. The program accommodates a maximum of 10 students from Luiss every year, with candidates ranked based on their academic score.

The following description of the requirements and selection process is intended to provide guidance to interested students. These parameters are subject to change and will be considered definitive only when published in the official Call for Applications.

## Requirements

In order to access the selection process, students are required to hold the following:

- **Average Grade:** at least 25/30
- **Course Completion:** pass all first-semester courses by the end of the Winter Exam Session 2024/2025 and all first-year courses by the end of Summer Exam Session 2024/2025<sup>6</sup>
- **English Language Proficiency:**  
Minimum B2 level certified by one of the following certificates:
  - a. **TOEFL** min. 75/120 IBT
  - b. **IELTS** min. 6.5
  - c. **Cambridge: CPE, CAE, FCE** min. grade B
  - d. **Duolingo** min. 110/160
  - e. **Accademica linguistica Trinity School di Roma:** B2.4 level
  - f. **Luiss University Language Center:** B2.4 level
  - g. **International Secondary School Diploma totally taught in English**
- Have no pending administrative issues with Luiss.

# Selections & Admissions

## Selection Criteria

Eligible applicants will be ranked according to the academic score. Such score will be calculated according to the following criteria:

Criteria	Percentage	Details
WEIGHTED GPA	40%	Starting from the minimum valid grade (30/18).
ENGLISH LANGUAGE LEVEL	25%	To be evaluated according to the CEFR levels.
MOTIVATION INTERVIEW	25%	Analysis of motivation of the student, including the personal statement, to be held in mid-February (final date to be confirmed)
GERMAN LANGUAGE LEVEL	5%	To be evaluated according to three thresholds: A (A1 and A2), B (B1 and B2) and C (C1 and C2).
FRENCH LANGUAGE LEVEL	5%	To be evaluated according to three thresholds: A (A1 and A2), B (B1 and B2) and C (C1 and C2).

## Admissions & Enrollment

Once admitted to the program, Luiss students will be required to apply to the partner universities in order to be officially enrolled in all three institutions. Students are therefore requested to make sure that they complete the procedure according to the instructions and timeline requested by each institution.
